1. Portfolio total return is the rate of return from changes in market value (price return) and earned income, such as dividends or coupon payments. Standard portfolio and group level returns are weighted averages of security returns using portfolio beginning weights and are linked daily over the calculation period. 2. Contribution to return is derived by multiplying the beginning weight of a security by its return on a daily basis and compounding this product over time. Portfolio and Sector/Country level contributions are the sums of security-level contributions.
